

CHAPTER I

Having been notified that I was accepted and saying goodbye to my one and only Sweetheart thru out my life, and also my mother and sister, I boarded a train for Philadelphia.

Arriving in Philadelphia, my orders were given to an Army Sgt., who took charge of 15 inductees. We departed and arrived at an induction center. Processing began at a supply depot where you follow each other in single file, you are instructed to hold your arms straight out and follow the man ahead of you, as you proceed the first thing you get is a duffel bag which is put into your right hand, after that everything is almost thrown at you including boots, that's the only item they ask you for your size. You get the whole wardrobe, green fatigues, underwear, Dress khakis, Army packs, wool socks, overcoat – the WORKS At the end of the depot was a Sergeant who marched us to our barracks. At this time, we were designated bunks.

CHAPTER II

Our bunks were naturally not your run of the mill bed you were used to at home, however, they were serviceable.

The Sgt. of our barracks came in and announced himself very cordially. I found out later that his job could have been very enviable and realized that all he was required to do was separate us as we came in to our various assignments. He was performing a separation phase of this first step.

All the occupants of my barracks were not given a chance to get acquainted for an hour? Second day? our group began to dissipate. At that point in time I had never heard of the old cliché, DO NOT VOLUNTEER FOR ANYTHING IN THE ARMY.

My thoughts wandered back to the brochure. I had heard about the paratroops. It said excellent training, extra pay for jump status and 3 day missions and back to the base. In other words Jump do your Job and return, plus \$50.00 a month. SOUNDS GOOD?? WRONG"

CHAPTER III

By the 5th day, I was the only one left in the barracks except for the Sgt. My assignment was to keep the barracks clean. The Sgt. told me that as soon as there were enough volunteers at least 12, we would be on our way.

It was the 10th day and finally the Sgt. told me to get my gear together and report to another barracks. When I arrived at the barracks and reported to the Sgt., he lined us up and called the oldest volunteer, and informed us that he was in charge of us as an acting non-commissioned officer.

The next morning we loaded on an army truck that transported us to the train station. After boarding the train our acting Non Commissioned officer opened the orders, we were going to a place called Camp Toccoa Georgia. Finally the first peg of our unknown future. Would we survive?? WHY NOT!

CHAPTER IV

THE ARRIVAL: When I use the term arrival it is used very loosely. Getting off the bus we immediately learned the subtle terms of military jargon. Three examples are, IMMEDIATELY, DOUBLE TIME AND GIMMEE 25 PUSH UPS- on the double was meant for all occasions even if you were not ordered to do it you did it automatically.

We were about to enter the "Twilight Zone" or weeding out process. As we hit the ground from the bus, a couple of Sergeants met us, told us to drop our Duffle bags, got us in formation and immediately double-timed us to an area where a tower loomed ahead and in single file we climbed this tower. One by one, we entered the tower and two Non Commissioned officers, strapped a harness on us and pushed us out the door. It was quite an experience but, really more surprising than dangerous, the harness was attached to a guide wire and you just slid down to the ground. Again, there were two non-commissioned officers there to unhook us and told us to double-time back to the tower. The repetition continued. I went up six times and that was a maximum amount to pass the first hurdle, however, we lost five of our group in that foray.

CHAPTER V

Having decimated our rank in this initial venture, another Sgt. took us by the hand and immediately double-timed us to the dispensary and we underwent an anatomical procedure that missed absolutely nothing. X rays, Blood test, nerve ending tests, Cardiograms, "Do you like Girls" questions, nothing was overlooked and I Mean Nothing.

We lost three more of our group. The Sgt., double-timed us to the barracks and we entered a barracks and sat down. As we looked straight, there was a table with four men seated there, three Second Lieutenants, and one First Lieutenant.

These officers were going to question us one by one. The questions were of all varieties and situations, these were all answered and I was the last one to be questioned. None of us knew what was asked and answered by each one. I was the last one, I was questioned by the First Lieutenant, and he finally asked me if I could obey any order , and I proudly answered "Yes Sir". He responded to me "I know you will". I looked straight into his eyes and



I have never seen blue eyes that twinkled as brightly as his. At this time a Second Lieutenant said I'll take this man.

I forgot to mention the one odd question which probably was a deciding factor in my being chosen by my 2nd Lieutenant., was his order to go over to the wall and hit it with all the force I had. At the time, I didn't know anything about studs or building factors so I answered "Yes Sir" and went over to do it, I pulled my arm back made a fist and began, and I heard a voice say that's fine soldier. I felt good about myself, however, the worst was yet to come.

Dear Bob, Great Mail Call. Keep up the good work.

Note to **Jodi Longo Jennings**: Your father and I did many things together and most of them are set forth in the citations Bob listed for you to click on. Since these accounts are detailed, I won't try to rehash.

After the jump in S. France, he took care of **Col. Paxton** better than any orderly could. He got the grub, cooked it, saw that the colonel's uniforms were in good shape. He really liked the job or was a good actor. It put him in the center of things that were going on in 3rd Bn.

I last saw him at the reunion in Ft. Benning. He looked to be in good shape. We corresponded some and he told me about working, I think, at JC Pennys and raising some beef cattle on a small acreage. You must have seen some of the results on the table.

Note re **Bob Morgan** and Manhay: There apparently were more than one Sgt. Brown. Donna's father [Sgt. Silas Brown] was Bob Reber's platoon sergeant, 3rd Bn. 81 mortar platoon all the way through. The Polish-American captain whose name I always misspell (but Kim has it right) commanded G Co. after he and **Hooper** swapped places and Hooper became the S-3. We will be interested in Bob's write up, but this gives me two questions. We attacked and held Manhay in the wee morning hours of darkness on December 27,1944. What went on before we took it is confusing, but I have a loose handle on it, some of I remember from reading a book on General Rose, Commander of 3rd Armored Division, to whom Bill Boyle reported in Manhay when his headquarters was there a while before the 3rd Bn. attack on the 27th. They gave Rose and the 3rd Armored a 14 mile front to defend and then reassigned his two combat commands, A and B, leaving him with C, composed of a few recon. tank units, his communications units and little else. In addition to this, higher Hq. changed the defensive borders of the units so who was in charge of defending Manhay was unclear. In this confusing situation, Bill Boyle and Don Frasier separated in the fast move forward and each commanding parts of the 517th1st. Bn. assisted Rose in holding most of the line. In the confusion, however, Manhay fell to the SS armored outfit the 3rd Bn. removed in our Dec. 27 attack. We were told that previously two regiments in separate attacks had failed to do the job. Manhay was the center of an important net of highways we needed to hold to prevent the Germans from going on to Antwerp.

This raises my second question about Bob's write up. The first being that the dates mentioned by Kim precede the 27th of December. During this time period the 3rd. Bn. operated without G Co., which was ordered to guard Ridgeway's 18th Airborne Corps CP. If **Bob Morgan** was with G Co. at that time he did not participate in taking and holding Manhay. Perhaps his write up will make this clear.

Hope I haven't confused everybody including myself.

Now that I look around, there were a number of Brown's.

I just assumed that since **Bob Morgan** was with G Company, the only Brown like that I could find was **Sgt. Silas Brown** of HQ/3. But Howard is sure that Silas stayed with **Reber**.



I did find 2 other Browns in the 3rd Bn, but they were in I Company, and not Sgts.

And I forgot about **Fred Brown**. He was with the 460th.

And there's Cpl. **Joe David Brown**, the author, also with the 460th.

There was the 517 chaplain Charles Brown.

And Tom McAvoy mentioned a **Sgt. Harlan Brown** of the demo Platoon, which I think was the 3rd Bn. Maybe that's a possibility.

Howard seems confused by the whole account, especially the dates, and we know how sharp his memory is. I guess we'll have to wait for the story and see what emerges.

Now I'm really curious.

Mr. Barrett,

To answer (a little bit) that question regarding **S/Sgt Howard M. Daniel** in MailCall # 2093, I found him listed in H Company, 517th PIR, as a Sgt, ASN - 33856350, MOS 7745 (Rifleman) in the passenger list of the SS MADAWSKA VICTORY, sailing from Le Havre, France on August 12th, 1945, and which brought back the 517th PIR to New York after the end of war in Europe.

According to his enlistment record, mr. Howard M. Daniel enlisted on July 5th, 1944 in Richmond, VA.

I hope this will help a little bit his children.

It's on page 13, passenger # 25, can you see him?

I have the transcript of Morning Reports for H Company (the one from your website), and checked with name + ASN, and apparently, there's no **Howard M. DANIEL** in that Company from May 1944 up to march 1945.

Maybe he was from another Company in the 517th PIR, or even from another PIR? I check my Pulles Roster for the 101st A/B Div, and he is not listed there. I also checked all the "indexes to the General Orders" from 82nd, 101st, 13th and 17th A/B Div, and he was not awarded anything from these Divisions, not Silver Stars, no Bronze Stars and no Purple Heart. That could have helped.

It seems like his son/daughter has it's Separation papers, maybe he/she can check what Campaigns he is credited for, it will help find out if he saw combat with the 517th. There should also be a listing of his awards there, with indication of the authorities that awarded them, and that could help out a bit as well...



Let me know if you have problem finding Mr. DANIEL's name in the embarkation roster, I might have a different copy (from Ancestry).

Thanks, Christophe. I found it. And now I know what MOS 7745 means! A 745 is a rifleman, but a 7745 is a parachute-qualified rifleman.

I agree with you. I have no signs of Howard Daniel in my records, but that is mostly the Xmas roster, the incomplete casualty reports, and whatever other photos and stories people have sent in. But those discharge papers and now the Madawaska manifest do confirm that he joined and ended with the 517 H Co. Good, I would hate to have disappointed her. It would be nice to confirm if, when, and where he saw some action in Belgium or Germany, but that might never happen.

I asked Donna the same question you are asking: Don't the discharge

papers have more details? Usually they have the unit, campaigns, medals and sometimes weapon skills. If I hear more from her I will.

PS: You're not on my weekly MailCall list. How did you happen to pick up #2093?





Hi Bob.




Dear Bob

I thought you might be interested in this photo of Col de Braus that I took from the airplane the other day. Not the best, but I happened to snap it as we flew over.


This photo gives a good impression of how savage the terrain in that area is. Sospel is visible in the background.
