





Lory and Dick,

You're probably not the only ones who have missed some recent MailCalls. I have not changed anything on my end, but I do know from years of sending them out with Ben, that the various email providers keep adjusting their methods to avoid spammers, and occasionally some of them think that the MailCalls might be spam. Ben would get very frustrated when he would see emails from his aol account rejected one week by comcast accounts, and the next week by charter.net, for no apparent or consistent reason. Then the next week, they would be okay, or a different ISP would reject them.

I thought I solved the problem by breaking the sending into 4 separate emails, each being sent to less than 100 people. This has been working for over 2 years, until the last few weeks. I'm not sure why. Most people, I think, still receive the emails, but at least a couple of people have not received some lately. Also, I do test each of the mailings by including myself in each of the 4 groups, so if I receive the 4 emails after I send them out, then I know that the MailCall has gone out correctly.

So the problem is not with the email itself, but with the way your individual email system tries to trap spam. I'm not sure what to do, and hope that it will resolve itself soon. In the meantime, just remember that you can always find the MailCalls at: www.517prct.org/archives
