Monday, Oct. 14, 2013:

My wife and I just returned from the Mall to observe the Million Veteran's March on Washington. There were no million veterans by any stretch of the imagination and not even close to the Memorial Day Rolling Thunder ride with thousands of supporters of the military. We attended because my wife's uncle was killed in the Invasion of Normandy in a tank. My older brother was a paratrooper with the distinguished 517th Parachute Combat Regiment Team Company H. So we can in respect to them and others.

What I saw today distresses me in the Administration's perception and disparate treatment of the veterans vs. other groups that descend on the Mall. I have lived in the Washington, D.C. area since 1989 and have never seen the posturing of security police against any group like this excepting those militant groups that get themselves arrested. Today I saw a armored vehicle at the White House and later in front of the WW II Veteran's Memorial (I was unable to take a picture of the vehicle). There were mounted police in Lafayette Park across from the White House which I have provided with a picture. This was for the appearance of the Veterans of the United States Military in the Mall!

I arrived a tad late to the White House on Constitution Avenue when the Veterans marched to the White House. We spoke with some veterans who described the scene when the veterans who removed the barriers at the WW II Memorial brought them to the White House and placed them in front of the WH fence where they were rushed by the security police. Some other veterans who were nearby rushed to the scene and caused the security to back off and not confront the vets. The mounted police came upon the group as a backup as well as the armored vehicle. There were a number of police cars and vans on the side street of Lafayette Park. The White House roof top rifle snipers who usually at their post on the roof of the White House showed an obvious presence ( see picture).

Who was the threat? It was apparently our military veterans who fought and protected us from oppression outside the United States and who must have been perceived as a security threat to somebody to be subjected to intense security scrutiny as though they were Middle Eastern terrorists protesting the Administration.

I do not understand the attitude of the Administration towards veterans who merely wish to air their concerns and be able to assemble peacefuly as other groups have done through the years. But, never have I seen the security presence as I have today and I am not one to exaggerate. I wonder what the grandfather of the President, who served in WW II, would have said to see his comrades in arms treated like this.

My wife and I were proud to see the peaceful behavior by the vets from all wars as the visited the memorial sites with their families and friends. Some proudly wore their uniforms (see picture).

I normally would not write about what I experience in Washington, D.C. over the years but something is really wrong with our Country when our veterans of all the wars are being scrutinized and with the ramped up security for whatever reason during their modest" Million Vet March". I have never witnessed such a treatment of the veterans in all years I have been here except in these recent months.

#### Veterans tear down memorial barricades

#### Protesters seize fencing at monuments, pile it at White House

Ernest Adkins left his wife and 4-month-old baby in Blacksburg, Va., Saturday to drive four hours to Washington. The U.S. Army veteran then spent Sunday morning marching through the city, where he wound up standing in front of the White House for three hours, holding a sign over his head that read "Respect our Vets."

He was one of the hundreds of veterans who descended on Washington for the "Million Vet March on the Memorials." Frustrated with the government shutdown, protesters tore down barricades from closed monuments and memorials and piled them outside the White House. It was the latest burst of public outrage over lawmakers' inability to compromise over the budget, leading to a shutdown that has crippled government services and left tens of thousands of federal employees furloughed.

With a modest disability check that may be cut off within weeks and severe health problems after doing two tours of duty in Iraq, "I don't know what to do to bring in income," said Adkins, 32.



The closure of monuments throughout the city has been one of the most visible symbols of the shutdown.

"They are our memorials, and they belong to us," said Steve Nevels, who drove six hours from West Virginia to participate in the demonstration. Nevels, 39, said he helped take down some of the barricades that were blocking the World War II Memorial, where the group started its march at about 8 a.m. Protesters then made their way to the Vietnam Veterans Memorial and the Lincoln Memorial before converging at the White House shortly before noon.

"Don't Tread On Me" American Revolution-era flags before moving on to the U.S. Capitol a few hours later. The demonstrations were mostly peaceful, with a few short clashes between police and protesters in front of the White House as officers put up temporary fencing along the sidewalk.

U.S. Park Police estimated there were 100 to 200 protesters and said there were no arrests.

Michael Ashmore drove 24 hours from Texas for the march. The 24-year-old former Marine served four years in Afghanistan and said his disability benefits stopped about a week ago.

Ashmore says he suffers from

post-traumatic stress disorder and is "living one day at a time" without his disability check.

Politicians, Ashmore said, "just need to get their priorities straight and look out for everybody else instead of themselves.'

At about 3 p.m., Adkins prepared to wrap up his protest and head back home to his family. Holding back tears, he said his household has cut back on expenses, spending money mostly on diapers and formula for his son.


"Stop being petty," Adkins warned lawmakers. "We're talking about childish games that are affecting the American people." lynh.bui@washpost.com

Hello Trevor, I haven't found a lot on Cpl. Lang on my website records, but here is what I can tell you:

- He was with C Company, and is listed on the 517<sup>th</sup> Christmas 1944 roster: <u>http://517prct.org/documents/xmas1944/xmas1944.htm</u>
- He was KIA on 24-Dec-44 and is buried in the Henri-Chappelle Cemetery in Belgium. <u>http://www.abmc.gov/search/wwii\_list.php</u>
- His army serial number is 36741514

• I tried to look him up in the NARA WW2 enlistment records, and I see 9 Edward J. Lang's, but none with that serial number: <u>http://aad.archives.gov/aad/display-partial-</u> records.jsp?s=3360&dt=893&tf=F&bc=%2Csl%2Csd&g=lang+edward+j

• I do have a note that his KIA was listed on a morning report along with many other casualties in that battle.

- We have several 517<sup>th</sup> histories. Probably the most detail is the "Record of Company C", which does include some brief info on when and where Cpl. Lang was killed. (Although it is listed as Cpl. E. W. Lang") <u>http://517prct.org/documents/c co history/c co history.htm</u>

#### Taps – Frank Gallucci



Frank L. Gallucci, Sr., 88, passed away Thursday, October 10, 2013 at Lutheran Hospital in Fort Wayne. Born in Detroit, MI, Frank was a graduate of the University of Detroit and its law school. He was a World War II combat veteran serving in the 517th Parachute Combat Team, attached to the 82nd Airborne Division and the Fifth Army in Berlin following the war. He had six combat jumps and fought in the Battle of the Bulge, receiving the Purple Heart multiple times. He also received the Bronze Star, Croix de guerre and numerous other military awards. He was Executive Vice President of Essex Wire, Founding Partner of Gallucci, Hopkins & Theisen, and Retired Of Council for the Barnes & Thornburg Law Firm. He was a member of the Indiana. Michigan and D.C. Bar, where he argued cases before the U.S. Supreme Court. He also served as Chairman of the Board of St. Joseph College and was a Board Member of Ohio Art and the Allen County Sherriff's Merit Review Board,

St. Patrick Catholic Church, Arcola and St. Elizabeth Ann Seton Catholic Church. Surviving are his wife of 60 years Rita Gallucci of Fort Wayne; son Louis P. Gallucci of North Las Vegas, NV; son Frank L. (Tina M.) Gallucci Jr. of Fort Wayne; daughter, Sandra M. (Raymond) Wardell of Fort Wayne; grandchildren Alex (Andrea) Gallucci, Olivia Gallucci, Sophia Gallucci, Maria (Lance) Lockstadt, Dante Gallucci, Dominic Wardell, Philip Wardell, Victoria Wardell; sister, Mary (Sam) Mininni of Livonia, MI; sister, Dorothea Siedlik of Novi, MI; brother, Richard Gallucci of NC. Frank was preceded in death by son, Peter F. Gallucci; son Michael Patrick Gallucci; parents Luigi and Maria Rose Gallucci. #### Military Humor
