Dear Sir,

I am hoping to obtain some information concerning an event in or near Trois Ponts, Belguim. My father, **Elam J Cronquist**, received a Bronze Star for heroic action, on January 3, 1945. It was upgraded to include a "V" Device and Oakleaf Cluster in 2004, when I obtained his duplicate medals. The citation reads;

For heroic achievement in action near Trois Ponts, Belgium, on 3 January 1945. During an attack, Private First Class Cronquist rushed forward through intense machine gun and mortar fire to the aid of a wounded comrade. After dragging the man to cover and administering first aid, he received permission to assist the wounded and blinded Soldier to the battalion aid station. Private First Class Cronquist was also wounded and over his protests, was given aid, but only after he was sure that his comrade was in a safe position. His quick thinking undoubtedly saved his comrade's life. Private First Class Cronquist's exemplary performance of duty in active ground combat was in keeping with the finest traditions of military service and reflects great credit upon himself, the 517th Parachute Infantry Regiment, and the United States Army.



I have two questions. First is there any way of finding the name

of the solider my Dad risked his life for? I know that there were quite a few casualties during this attack. And secondly, I know my Dad was wounded, and I'm hoping to find out when he was returned to duty.

Thank you in advance for any information you can find regarding my Dad.



Army – the "V" is worn solely to denote "participation in acts of heroism involving conflict with an armed enemy"

The bronze "V" is positioned to the right of any bronze or silver oak leaf clusters from the wearer's perspective, or positioned in center of the service ribbon if worn alone. The following examples depict decorations that were awarded with the "V" Device in at least one instance:





Hi Shanna,

I dig some digging around and found some info for you about the Trois Pont battles, but not the exact answer. There are several account of the battles around Trois Ponts in early January. The most complete are in the following:

Paratrooper's Odyssey - A History of the 517th Parachute Combat Team

The Operations of the 551st PIB (attached to the 82nd and the 517th), in the Attack on Trois Ponts, Belgium, 2-7 January 1945

'Battling Buzzards' : The Odyssey of the 517th Parachute Regimental Combat Team 1943-1945

Unfortunately, these accounts are from various units but not directly from D Company witnesses. Battling Buzzards recounts the story from some of the 2nd Battalion including **Dick Seitz**. And **Bill Boyle**'s 1st Battalion joined the battle and that is where **Bill Boyle** was seriously wounded. And my Dad, Ben Barrett and 16 others of H Company were also wounded in nearby Bergeval on January 5th, but there are few details of their participation either.

Needless to say, this was one of the toughest and costliest battles for the 517th. **Dick Seitz**, Commander of the 2nd Battalion said, "There was a shortage of ammo and we never had an opportunity to make daylight reconnaissance. We arrived so late in the day we were only able to draw a map plan, after talking to the 505th. That day at Trois Ponts was the second worst day of the war for me and the second Battalion."

The one item I did manage to find, thanks to Mike Wells, is the Morning Report for D Company on January 3, 1945, which is attached. You can see from the report that 17 men were wounded in that battle with your Dad. So one of those men is probably the one that your Dad saved. Surprisingly, despite the casualties, none of D Company were KIA that day.

Also, you should look at the <u>Mike Kane photos of D Company</u>. Several of the men in these photos are also listed as wounded on the D Company 03–Jan Morning report with your Dad, including James McWilliams, Robert Davis, Lloyd Henry, John Sarti. Maybe you can find your Dad in some of those photos.


Dear Bob,
